# 1. Future Meetings(for endorsement): Resolution IRG 30.1

The following gives the IRG future meeting schedules:

# 2. CJK Ext B Multi-column Code Charts(for information): Resolution IRG M30.2

The IRG notes China and TCA requested a longer time for updating their fonts to follow the potential glyph policies and to avoid introducing unification problems.

The IRG resolves to restart the review of CJK\_B in early 2010 after the fonts from China and TCA are ready and the review is to end in 2012.

# 3. CJK Multi-column Code Chart Formats(for endorsement): Resolution IRG M30.2 and M30.3

With reference to IRGN 1458 and WG2N3408, the IRG resolves to adopt revised formats for multicolumn code charts as follows:

#### 3.1 CJK and Ext. A

Use 2 columns as suggested on page 5 of WG2N3408 with heading names and order specified below:

#### 3.2 Ext. B

Use 4 columns(rather than 5 as suggested on page 7 of WG2N3408) and add an additional sub column to show original glyphs in ISO/IEC 10646: 2003

# 3.3 Ext. C, Ext. D, and UNC

Use 5 columns suggested on page 7 of WG2N3408.

# 4. CJK Ext D Work(For information): Resolution: IRG 30.4

Ext. D work is in progress and Version 4.0 should be completed for review at IRG

# 5. CJK Extension D with inclusion of 2 Malaysian characters (For endorsement): Resolution IRG 30.4

Two characters from the Chinese Language Standardization Council of Malaysia (N1455) are accepted to the CJK Extension D provided their submission will conform to the IRG Principles and Procedures. This acceptance does not imply that more characters can be added to CJK\_D in the future.

Endorsement by WG2 is needed for the inclusion of Malaysian characters is needed. The IRG instructs the Rapporteur to clarify with WG2 on the multi-column format with regard to a potential inclusion of a Malaysian column.

#### 6. Urgently Needed Characters(For information): Resolution IRG 30.5

The UNC block is progressing in a timely manner. Two rounds of reviews will be conducted to produce Version 3.1 for review in IRG #31.

# 7. Review and Elaboration of Annex S (For information): Resolution IRG 30.6

Review and discussion on Annex S revision were conducted in IRG #30. One round of feedback and revision will be done for further discussion at IRG #31.

#### 8. Development of IRG Principles and Procedures (For information): Resolution IRG30.7

Review and discussion on IRG PnP were conducted in IRG #30. Two rounds of review and feedbacks will be done for further discussion at IRG#31.

#### 9. Old Hanzi Work(For information): Resolution IRG 30.8

Oracle Bone inscriptions from Radical 281 – 400 will be consolidated and discussed in IRG #31. Old Hanzi Principles and Reference Version 3 will be produced for discussion in IRG #31.

#### 10. Five Un-encoded HKSCS Characters(For Action): Resolution IRG 30.9

The IRG resolves to accept the HKSCS characters (IRGN1405R and WG2N3513). The IRG instructs the IRG Rapporteur to submit the five un-encoded HKSCS characters to the WG2 separately for inclusion in the ISO/IEC 10646.
