#### **Resolution IRG M39.1: Future Meeting Schedules**

The IRG resolves to adopt the following meeting schedules:

## Resolution IRG M39.2: Editorial issue on CJK Unified Ideographs (IRGN1884, IRGN1896)

**Unanimous Action:** China

The IRG requests China to report to WG2 about the deletion and modification of the G-source reference of characters agreed in IRGN1896.

## Resolution IRG M39.3: CJK Extension E Project (IRGN1881, IRGN1896, IRGN1905, IRGN1908)

Unanimous Action: IRG Technical Editor

The IRG accepts review of CJK E related issues in IRGN1896 and instructs IRG Technical Editor to forward the modifications to ISO/IEC 10646 project editor by 2012-11-16 for the production of the CJK Ext. E code chart. The IRG accepts IRG N1905 regarding the three pending cases on stroke count and unifications at the last meeting.

Resolution IRG M39.4: Production of First Stroke information (IRG M38.7, IRGN1916, IRGN1920)

**Unanimous Action: All Member Bodies** 

The IRG resolves to request all submitters to provide first stroke information for Ext. F and future extensions. The IRG further confirms that the final decision on the first stroke rests with the IRG technical editor.

Resolution IRG M39.5: Cursive like stroke shapes on the proposed glyph (IRGN1896 and IRGN1907)

**Unanimous** 

The IRG accepts all cursive characters proposed in IRG N1907 as Song/Ming style characters with one exception of JMJ-057632. Considering the importance of this character, IRG also accepts JMJ-057632 with a recording note as given in the editorial group report (IRGN1896).

Resolution IRG M39.6: CJK Extension F Project (IRGN1882, IRGN1883, IRGN1885, IRGN1886, IRGN1887, IRGN1888, IRGN1896, IRGN1899 including Feedback, IRGN1902, IRGN1907, IRGN1911 including Feedback, and IRGN1914)

**Unanimous Action: All Member Bodies** 

The IRG accepts submissions from China, Japan, ROK, and SAT and the review comments from the Editorial Report(IRGN1896). The IRG accepts the following CJK F working schedule:

- 2012-12-29: IRG members' chief editors submit fixed attributes (Excel or CSV) with First Stroke information to the IRG Technical Editor and the IRG Chief Editor
- 2013-01-18: IRG chief editor distributes CJK\_F v1.0(IRGN1921) which is split into two parts to IRG members' chief editors. Two reviewing groups for the two parts are set as below
  - ➤ Group 1: China, ROK, HK, Vietnam, Unicode
  - ➤ Group 2: Japan, SAT, TCA, Macao
- 2013-03-15: IRG members' chief editors submit review comments to the IRG chief editor
- 2013-03-29: IRG chief editor distributes consolidated comments to IRG members' chief editors.
- 2013-04-05: IRG members' chief editors submit feedback to IRG chief editor.
- 2013-04-12: IRG chief editor distributes fixed consolidated comments to IRG chief editors.
- 2013-04-26: IRG chief editor distributes CJK\_F v1.1 (M set and D set)(IRGN1922) to IRG members' chief editors.
- IRG#40: Discuss explanations from IRG editors

### Resolution IRG M39.7: Definition of evidence in IRG PnP (IRGN1906)

#### **Abstain by ROK**

The IRG accepts the proposal in IRG N1906 and resolves to accept, at its own discretion, characters from implemented systems in e-government initiatives which satisfy certain terms and conditions stated in IRG PnP v6 Annex G.4. The IRG agrees to discuss on how to address the issue of personal information used as evidence in the future.

# Resolution IRG M39.8: IRG Principles and Procedures Revision (IRGN1823 including all Feedbacks and IRGN1901, IRGN1920) Unanimous

The IRG resolves to accept IRGN 1920 as IRG PnP version 6 to take effect immediately. The IRG requests member bodies to give feedback on further improvement of IRG PnP Version 6 and submit feedback by 2013-04-19 and instructs its Rapporteur to consolidate the input and produce a revision draft by 2013-05-02 for IRG #40 Review.

#### Resolution IRG M39.9: IDS syntax (IRGN1900, IRGN1896)

#### **Unanimous**

The IRG accepts comments from ROK and invites Mr. Taichi Kawabata to produce a chart with necessary information as stated in IRGN 1896 of PUA characters for

components which are being used in IDS for IRG editors' review. The IRG will consider making a proposal to WG2 to add these components to UCS at IRG#40 or later.

## Resolution IRG M39.10: IRG Working Document Series Update (IRGN1839 including Feedback, IRGN1896 and IRGN1918)

#### Unanimous

The IRG accepts ROK and HK comments on IRG1839. The IRG asks Mr. Taichi Kawabata to update the IWDS\_summary and all UCV lists to reflect these comments.

Resolution IRG M39.11: IRG's feedback to WG2 regarding IVD registration by UTC(WG2 N4075) (IRGN1757 including Feedback, IRG N1783 and IRG N1889)

#### Unanimous

Regarding IRG N1889 (WG2 N4075), the IRG concludes that the UK position is very close and supportive to the IRG position. The IRG further instructs the Rapporteur to report to WG2 the IRG position.
