This paper contains two separate draft editorial corrigenda. They are submitted to WG2 in response to Action Items from the London meeting.

1. CJK compatibility ideographs

Two proposed new characters were omitted from the FPDAM for Amd.17 of ISO/IEC 10646-1 (CJK unified ideographs extension A) because they are already present in the First Edition, in the block CJK COMPATIBILITY IDEOGRAPHS. But the details for this block do not show the sources of these characters, as for characters in the the main tables of CJK unified ideographs in clause 26.

WG2 agreed to insert entries in Annex P (Additional information on characters) to provide the source data for these two characters. Accordingly the following amendments are proposed.

In clause 25, Table 112 - Row FA (page 239), amend the following entries by inserting an * symbol after the final word, as shown below:

- 1F CJK COMPATIBILITY IDEOGRAPH-FA1F
- 23 CJK COMPATIBILITY IDEOGRAPH-FA23

In Annex P, before the entry FFE3 FULLWIDTH MACRON, insert the following additional entries:

FA1F CJK COMPATIBILITY IDEOGRAPH-FA1F

This character should be considered as an extension to the block of characters CJK UNIFIED IDEOGRAPHS EXTENSION A (see clause 26). It is not a duplicate of a character already allocated in the blocks of CJK Unified Ideographs, unlike many other characters in the block CJK COMPATIBILITY IDEOGRAPHS. 2. Bangjeom (Old Hangul) tone marks

At meeting 35 (London) WG2 accepted the recommendations regarding Bangjeom tone marks in WG2 N1738. Accordingly the following amendments are proposed (see WG2 N 1796 for current text).

In clause 24.1 "Hangul syllable composition method" assign the the number Note_1 to the exisiting Note, and insert a new Note 2 as follows:

NOTE 1 - Hangul Jamo are not combining characters.

NOTE 2 - When a combining character such as HANGUL SINGLE DOT TONE MARK (0000 302E) is intended to apply to a sequence of Hangul Jamo it should be placed at the end of the sequence, after the Hangul Jamo character which completes the syllable block.
