This is a summary to IRG activities as listed in WG2 N3131.

### 1. Future Meetings

WG2 has approved IRG #27 to be held in Taipei, Taiwan (TCA), 2006-11-27 ~12-1. Due to visa problems raised by PRC (See WG2 N3133), IRG 26 has decided to change its meeting schedules to the followings and request endorsement from WG2.

IRG #28 Taipei, Taiwan (TCA), 2007-6-4 ~ 8

IRG #29 San Jose, California (USA) 2007-11-12 ~ 16 (preferred, needs to confirm with host)

IRG #30 Busan (Republic of Korea), June 2008 (tentative, needs approval from authority)

IRG #31 Kunming, Yunnan (China) November 2008 (tentative, needs approval from authority)

IRG #32 IRG is seeking host, June 2009

### 2. CJK Ext C1 progress Submission to WG2 Meeting No. 49 (For review and feedback/instruction)

The C1 work has made its first submission to WG2 with 4,219 characters which were unified and quality assured using Ideographic Description Sequence and (other measures). Document WG2N3134 is the Summary Form for C1 Submission with two attachment files. Attachment A (in three parts) listed all the characters in C1 in multi-column presentation. Attachment B is a summary form to indicate the source of these characters from the submitting members. As requested by WG2, all member bodies have submitted their evidence files. However, as they are quite many different sources, these files are not submitted to WG2 (as IRG cannot consolidate them). However, these files can be downloaded directly from IRG site at

### **3. Status Old Hanzi (for information)**

Members have submitted samples of Old Hanzi for discussion at IRG #26 and first principles and submission guidelines are discussed. Members are requested to submit their collections at IRG#27. The IRG will also adoption of the ‘Old Hanzi Online Editing System’ to facilitate efficient review process and the proposed work plan with target completion date in IRG Meeting #32 in 2009.

### **4. CJK C1 and D Work Schedule (For endorsement)**

The IRG resolves to start work on CJK C2 after the IRG #26 Meeting. The IRG instructs member bodies to provide supplementary information for all CJK C2 characters.

### **5. Response to WG2 #48 on FDAM1 correction queries (for review)**

The IRG accepts the document IRG N1218 on proposed responses to the queries from WG2 covering the required corrections to source references and glyphs in FDAM1. IRG N1218 is submitted to WG2 #49 as WG2 N3132 for review.

### **6. Provision of Source Visual Reference Information (for information)**

The IRG requests member bodies to provide TrueType fonts as source visual reference information of Extension B characters to the IRG Chief Editor and the IRG Technical Editor for compilation before 31 October 2006. The IRG Technical Editor will prepare a draft list for review in IRG Meeting #27.
