1. Draft Agenda was accepted with the following modifications:
 3. Administrative matters:
 - a. Review action taken by WG2 and SC2 in Athens regarding IRG.
 - b. Review guidelines of how to operate as a member of JTC 1/SC 2/WG 2.
 2.
 - c. Election of officers: Rapporteur, Secretariat and Editor.
 4. Repertoire extensions to CJK ideographs.
 - a. Identify technical issues for future discussions.
 - b. Status reports by national bodies or organizations.
 - c. Mapping activity.
2. Japan will provide revised document of N 005 by Wednesday (6 October 1993) for adoption and forwarding to SC2/WG2 for approval to clarify the roles of Rapporteur, Secretariat, Editor and Secretary. The revision is confirmed with some modification and the revised document is registered as N 033.
3. Since the Convener of JTC 1/SC 2/WG 2 encouraged a smooth transition from CJK-JRG to IRG, IRG confirms the following:
 - a. IRG recognizes Rapporteur and Secretariat of IRG need to be from one country for logistic purposes.

Japan will be Rapporteur and Secretariat of IRG until the next JTC 1/SC 2 plenary meeting in Spring, 1995.

Mr. Kato, former standing secretary for CJK-JRG, will continue his work as Rapporteur for at least one more IRG meeting to keep a smooth transition, subject to the approval of the Japanese national body.

- b. China takes on the responsibility of Editor of IRG. China will provide the name of the Editor before the next IRG meeting.
- c. No one country can be Rapporteur, Secretariat and Editor at the same time. IRG encourages every country to provide officers to the IRG and to rotate the responsibilities of the officers.
- d. Appointment of officers of IRG should be synchronized with the appointment of SC2/WG2 officers at the SC2 plenary meetings.

4. After some discussion, IRG requested Japan to revise N 009 to clarify questions raised about the rules for extensions of the CJK Unified ideographs.. The revised document is registered as N 022.

5. The details on agenda item # 4 will be reported in the minutes of this meeting. Several documents were submitted which will be used as the basis for technical review and discussion in future IRG meetings. Several documents that were published as part of CJK-JRG proceedings have been registered as IRG documents.

IRG encourages TCA and HKITF to provide status/activity reports in future IRG meetings. IRG members who provided status/activity report include China, Japan, Korea and U.S.

6. IRG approves Japanese proposal in document N 007 for a new work item with modifications agreed to during the meeting and decides to forward it to JTC 1/SC 2/WG 2 for further authorization.

7. IRG accepts Japanese proposal in document N 008 on the preparation of an addendum for ISO/IEC 10646-1, with two modifications as agreed to during the meeting. IRG will forward the modified N 008 document to JTC 1/SC 2/WG 2 for further authorization.

8. IRG decided not to use N 010 as a reference since the document, which was submitted originally by Japan, was also withdrawn by Japan,

9. IRG recognizes that base documents for future discussion on extensions include the following:

IRG instructs its secretariat to circulate N 027 through N 030 to all IRG members based on the request from Japan. These documents has been circulated earlier as CJK-JRG documents but now have a new IRG number.

10. IRG reconfirms item 7 of document N 004 from China regarding future extensions.

11. Future meetings of IRG:

- a. IRG meeting # 2 will be hosted by Vietnam from 28 February 1994 to 4 March 1994. Backup for the meeting will be China.
- b. IRG meeting # 3 will be hosted by China from 19 September 1994 to 25 September 1994. Backup for the meeting will be TCA.
- c. IRG meeting #4 will be hosted by TCA in February 1995 after the Chinese New Year holidays.

IRG requests its secretariat to circulate the 2nd meeting notice within one month after the first IRG meeting after confirming the meeting date with the Vietnamese delegation.

12. Appreciation. The convener of SC2/WG2 expressed his deep thanks and appreciation for ITSCJ, and for the excellent services provided by the local host, Toppan Printing Co. Ltd. in Fukuoka. He also thanked the various attendees for their active participation and congratulated them on the results of their first meeting and wished them success in their future meetings.

The meeting was adjourned at 12:30 pm on Wednesday, 6 October 1993.
