Prioritization
=====

P1. IRG has agreed in principle to prioritize the category A vertical extension into three levels as follows:

Level I: Core(2,147) +
 G7(unique 99) +
 G3(unique 1,908) +
 TE(unique 1,453) +
 J (unique 246) +
 subset of S (unique 232) around 80% +
 subset of K (unique 946) around 70%

Note: To include the Core, G7, G3, TE, J, S, and K, the total would be 7,084. Since the total may be larger than what the minimum that WG2 can grant to us, Korea and Singapore have agreed to reduce their sets by around 30 % and 20 %, respectively. The subsets taken out of K and S will have the priority level II.

Level II: subset of K(around 30% of K) +
 subset of S(around 20% of S)

Level III: G5(unique 3,000) +
 T4(unique 660)

P2: Schedule: Submission of code partition lists into Level I and Level II must be done before Sept 15.

P3: When doing partitions from a source set into different priority levels, the code point(the code value) in the source set must not be changed.

M1. IRG has fully discussed the mission of IRG as requested by WG2 and decided on the scope of IRG and Program of work as follows:

Scope:

To prepare proposed texts for standards on ideograph related matters and submit them to ISO/IEC JTC1/SC2/WG2;

Program of Work:

- a) Finalize the text(repertoire) of Internal/Horizontal supplement of ideographs for ISO/IEC 10646-1
- b) Prepare the text(repertoire) of Vertical Extension of Ideographs for ISO/IEC 10646.
- c) Prepare the proposal concerning components of ideograph and related matters.
- d) Prepare the revision of Annex -- of ISO/IEC 10646-1 on rules of unification for Internal/Horizontal Supplementation.
- e) Provide the final code table of ideographs for ISO/IEC 10646-1 with high resolution including Internal/Horizontal supplement and Vertical Extension , when requested by ISO/IEC JTC1/SC2/WG2.

Components:

- C1: IRG concluded that components will be included in BMP of ISO-IEC10646, but as a separate set from Vertical Extension. All delegates are asked to submit their component sets. IRG agreed to accept the component proposal N211R as the draft base for discussion. The submissions should not duplicate with the existing coded set and every effort should be made to minimise the set.
- C2: All proposals shall be sent to Mr. Zhang Zhoucai before the end of Sept. 1995.
