The IRG resolves that in all future revision of font, font has to be submitted either as (i) delta font or (ii) full font with a report listing all glyph changes. All revised fonts

must be submitted with different file names and font family names. The code points must be UCS for already encoded repertoires.

Resolution IRG M35.3: Add Big-5 mapping to Unihan Database and Code charts (IRGN1736)
