Resolution IRG M38.1: Future Meeting Schedules

Resolution IRG M38.2: CJK Extension E Project (IRGN1841, (IRGN1824 and Feedback), (IRGN1829 and Feedback) and (IRGN1830 and Feedback, IRGN1875 and Feedback))

The IRG accepts the Editorial Group Report (N1864) on CJK Extension E with the following work schedule:

Resolution IRG M38.3: CJK Extension F Project (IRGN1813 and Feedback, IRGN1855, IRGN1858, IRGN1859, IRGN1865, IRGN1872, IRGN1873 and IRGN1874)

The IRG accepts the Editorial Group Report (N1865) on CJK Extension F. Member bodies are required to submit their CJK Ext. F characters by 2012-10-20 for review at IRG#39.

Resolution IRG M38.4: Font Submission Guidelines (IRGN1822)

Action: All Member Bodies**

The IRG instructs member bodies to study the requirements in IRG N1822 on font submission and ask the ISO/IEC 10646 Editor for clarification if needed. Member bodies are instructed to follow the requirements in future font submissions.

Resolution IRG M38.5: Total Strokes Submission (IRGN1790)

Action: All Member Bodies**

The IRG considers that total stroke count is locale dependent. It is not feasible to come up with an IRG agreed total stroke count as a submission requirement. The IRG considers the current practice of providing stroke count for the remaining component excluding the stroke count of the radical part to be sufficient.

Resolution IRG M38.6: IRG Principles and Procedures Revision (IRGN1823, IRGN1843 and Feedback)

Unanimous

Action: IRG Rapporteur/All Member Bodies

The IRG resolves to accept IRGN1823 Draft 2 and instructs its members to give feedback by August 15, 2012. The IRG further instructs its Rapporteur to produce IRGN1823 Draft 3 by October 15, 2012 for further verification by members for confirmation at IRG #39.

Resolution IRG M38.7: First Stroke of character submission (IRGN1823 and Feedback)

Unanimous

Action: IRG Rapporteur/All Member Bodies

The IRG resolves to ask the technical editor to assign the first stroke based on IRGN954AR and IRGN1105. In case of previously unseen components, the technical editor will take the conventions of Kangxi for first stroke assignment without regards to the submitter's locale conventions.

Resolution IRG M38.8: Handling Procedures of Urgently-Needed Characters (IRGN1843)

Unanimous

Action: IRG Rapporteur/All Member Bodies

The IRG resolves to refine Annex C of IRG PnP on Urgently-Needed characters submission requirements. Each submission from a member body shall include no more than 30 ideographs. Submissions that include more than 30 characters will be accepted at the sole discretion of the IRG.

Resolution IRG M38.9: Old Hanzi Expert Group (IRGN1836)

The IRG accepts the Old Hanzi Expert Group Report (IRGN1836).

Resolution IRG M38.10: Old Hanzi Principles and References V3 (IRGN1836Appendix_PNRv3)

The IRG noted the revisions made by the Old Hanzi group on the Principles and References and instructs the IRG Rapporteur to submit Old Hanzi PnR Version 3(IRGN 1876) to WG2 by 2012-09-21.

Resolution IRG M38.11: Dissolving the Old Hanzi Expert Group (WG2.M59.19 IRGN1846)

The IRG accepts the decision of WG2 to dissolve the Old Hanzi Expert Group and the removal of Old Hanzi related tasks from the scope of work of the IRG .
