1. **[K2144 = IRG N1839\_ROK] comments RE: IRG N1839 IRGWDS.**
  - ROK IRG committee is preparing comments RE: IRG N1839 IRGWDS.
  
2. **[K2164 = IRG N1900] comments RE: using PUA char in IDS**
  - ROK IRG committee reviewed WG2 N4234 and M59.03 which suggest to use PUA characters in IDS and made some comments [IRG N1900].
  
3. **[K2165 = IRG N1843\_ROK] comments RE: UNC process**
  - ROK IRG committee reviewed WG2 N4230 (=IRG N1843) RE: UNC process, analyzed it and then suggests a few things [for details, see IRG N1843\_ROK].

*WG2 N4230 (=IRG N1843), Proposal to establish a CJK Unified Ideographs “Urgently Needed Characters” process*
  
4. **[K2169 = IRG N1901] K2, K3, K4, K5 → KS X 1027-1, -2, -3, -4**
  - Since repertoire covered by the K2, K3, K4, and K5 sources have been standardized as Korean standards KS X 1027-1, -2, -3, and -4, respectively, the relevant portion of clause 23.1 of ISO/IEC 10646 need to be changed [see IRG N1901 for details].
  
5. **[K2170 = IRG N1884] possible errors in CJKU\_SR.txt**
  - ROK found some possible errors in CJKU\_SR.txt (2nd and 3<sup>rd</sup> ed of ISO/IEC 10646) and reported them in IRG N1884.
  - Suggested corrections for all problems except one China-related error have been provided.

– ROK IRG committee is preparing comments RE: IRG N1823, IRG PnP draft3
