The WG2 convener proposes to start a new program of work for the development of a seventh edition to ISO 10646. The new edition will incorporate the two existing amendments to the 6th edition of 10646 and will also add additional repertoire as specified below. It is expected that the 7th edition will be synchronized with a version of the Unicode Standard, probably Unicode version 18.0.

A starting repertoire is documented in WG2 N5249R and consists of the parts documented in yellow highlight. The following list includes that repertoire augmented with the proposed CJK Unified Ideographs Extension J corresponding to the IRG Working Set 2021 created by the Ideographic Research Group (IRG). It is important to note that this is just a starting repertoire and will be adjusted following additional work by WG2 experts.
